Preface

About this document

This document describes the messages deployed in the FINplus service as part of Standards Release 2025.

Deployment pilot future (swift.finplus!pf) – 19th of July 2025

Deployment live (swift.finplus) & Deployment pilot current (swift.finplus!pc) – 22nd of November 2025

Note: All FINplus messages require RMA to the exception of the tracking (trck) messages where no RMA is required.

The policy of the FINplus service is to support only one version of a message at any one time in the Live environment. The old version of a message is withdrawn from the FINplus service at the same time as the new version becomes available for live use. There is an exception for the penalties reporting message where the DRAFT4 and DRAFT5 versions of the semt.044 coexist.

The messages will be activated in the FINplus Pilot Future service for testing in July 2025.

The messages will be activated in FINplus Live in November 2025, with validation based on finalized usage guidelines.

In November 2025 it will be mandatory to receive camt.110 through Case Management with an embedded MT199 (Inflow Translation). Financial Institutions part of the Case Management closed user group have to reply with ISO 20022 camt.111, API or GUI through Case Management. The other financial institutions will respond serially with legacy MT messages on FIN. Inflow translation will not be provided for camt.111.
